#### **Treasurer's Report**

- Unreserved funds are approximately \$1M. At this time last year, the number was closer to \$650K.
- We're still expecting the BVA contribution.
- Current income exceeds budget projections.
- We're waiting on wildland reimbursements.

#### Chief's Report

- Current holiday pay policies favor the administrative staff over shift personnel (the three captains).
- One proposed policy would pay 10 hours for each holiday. This would cost approximately \$15K per year.
- An alternate policy would pay time-and-a-half for the captain working that holiday. This would cost approximately \$4K per year.
- We are looking into renting a service bay in Rollinsville. This would be shared with Timberline. Our share of the rent would be \$500/month.
- We rescued a cat from a tree.
- We responded to a wildland fire at West Magnolia.
- We responded to a pile burn that should not have been allowed due to the burn ban.
- A large hydraulic fluid spill was handled as a hazmat incident.

- We have a new PRN paramedic Mike Techentin.
- We went live on First Due for EPCRs and NFIRs.
- 5601 and 5617 are out of service. Timberline is loaning us one of their engines.

### Fire Marshal's Report

- Fire safety inspections completed for Eldora. There were fewer issues found than any year on record.
- Met with multiple fire marshals to share ideas and templates for First Due.
- Working on assessment matrix for Big Springs egress routes.

Proposed 2025 wages will increase from their current values.
