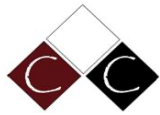

Please acknowledge that you understand and accept the following:
 -Seams are unavoidable and in some areas can be more obvious than in others, mainly due to lighting and the style of carpeting selected.
 -Scuffing of baseboards, paint, and wallpaper may occur during normal installation. Installer will use caution but will not be responsible for damage. Client is responsible for touch up.
 -Prices exclude floor preparation or otherwork necessary to correct unforeseen floor surface defects, not apparent during measure. Client will be advised of all extra charges at the time of install. i.e. ramps, floor patch, etc.
 -Moisture can cause havoc on any type of flooring, too much or not enough can cause flooring to fail and can void manufacturer warranties.
 -Door trimming and baseboard modification. Client is responsible for trimming doors and raising and lowering baseboards due to increase or decrease in carpet height.
 -Expect to see footprints, vacuum tracks and shading in carpet. These are unavoidable because of todays high luster yarns.
 -Moving furniture creates inherent risks to one's property and items may be broken, scratched, lost or otherwise damaged. Coventry Carpets cannot be liable for any damage that may occur during this process. Please have any item you deem valuable to you moved prior to installation.
-Coventry Carpets Installation Warranty: 3 Years from time of install on buckling for Nylon Carpets and 1 Year on Polyester Carpets. Coventry Carpets has the right of first refusal to fix, solve, any problems that may arise due to installation. Third party actions for fixing any issues will be at the cost of the end user. -Please notify us 72 hours in advance if you need to reschedule your installation. We will gladly reschedule on the first open date.
 -All promised install dates will remain on schedule unless unforeseen circumstances due to mill or freight delays, or act of God.
 -1.5% interest per month (annual rate 18%) will be added to outstanding invoices not paid within 30 days. Customer shall pay reasonable costs of collection, attorney fees, cost of suit incurred by Coventry Carpets to enforce payment of this invoice.
 -30% Restocking charge plus freight on all returned items. No returns on special order products (wool/funners)
