Patrick Richardson, Scott Papich and I met and went over the engine specs line by line in preparation for our prebuild meeting in Florida at the end of the month.

5631- work continues. The new pump should get mounted in the next week. Most of the gear that was removed for the remount was reinstalled by Capt. Wheelock

5650- had the on-board radio charger installed, the rear slide replaced and the grill guard removed in preparation for the winch installation. Laws1 is going to resell the grill guard and the drawer slide for us. Captain Faes built an SCBA mount and fire extinguisher mounts for the bed.

5652- has more codes and has a loss of power. We will have the mechanic continue to look at it. Should we consider replacing it with something newer?

5653- the plow continues to have problems; we will have the mechanic look at it next week.

Station 1's front door continues to be intermittent. I have ordered a new lock to fix the issue.
Captain Faes has run all the conduit for the new SCBA compressor. We still need to order a rotary phase converter. I am receiving conflicting information on what is needed. Once this is sorted out, I will get it ordered.

The mechanics shop area has begun being cleaned out.

3 of the lights that were installed in the high bays have burned out already, we had 2 replacements and Capt Faes installed them but now we need to purchase additional ones.

Our video laryngoscope died, it is no longer supported by the manufacturer. Capt. Moran has purchased new King Visions for all the ALS vehicles only parts have arrived so far.
